



**IMPORTANT INFORMATION & DISCLOSURE REGARDING GRADUATE
EMPLOYMENT AND SALARY DATA ON THE CALIFORNIA BUREAU FOR
PRIVATE POSTSECONDARY SCHOOL PERFORMANCE FACT SHEETS**

In compliance with regulations and requirements of the California Bureau for Private Postsecondary Education (BPPE), California College of Ayurveda (CCA) has prepared a School Performance Fact Sheet (SPFS) for each program based on eligible 2019 program graduates.

In order to provide the required data for the number and percentage of students employed in their field - as well as salary data of our program graduates - CCA sent a survey to 2019 program graduates. As is typical for almost all mailed, electronic and telephone surveys conducted by educational institutions, CCA was only able to reach a relatively small number of students (less than 1/3rd of all graduates responded). CCA does not know whether or not the non-respondents to our survey are employed in their field or not. Also, based on a relatively high non-response rate, CCA was not able to obtain salary data for these survey non-respondents.

We have reported only the employment and salary data from the respondents to our graduate survey. For reporting purposes, those graduates who did not respond are considered as “not employed” and earning \$0.00 dollars. **CCA is confident that the actual number and actual percentage of graduates who are working in their program field is significantly higher than what is reported on the SPFS.**

- “Number of On-time Graduates” is the number of students who completed the program within 100% of the published program length within the reporting calendar year.
- “On-time Completion Rate” is the number of on-time graduates divided by the number of students available for graduation.
- “150% Graduates” is the number of students who completed the program within 150% of the program length (includes on-time graduates).
- “150% Completion Rate” is the number of students who completed the program in the reported calendar year within 150% of the published program length, including on-time graduates, divided by the number of students available for graduation.
- “Graduates Available for Employment” means the number of graduates minus the number of graduates unavailable for employment.
- “Graduates Unavailable for Employment” means the graduates who, after graduation, die, become incarcerated, are called to active military duty, are international students that leave the United States or do not have a visa allowing employment in the United States, or are continuing their education in an accredited or bureau-approved postsecondary institution.
- “Graduates Employed in the Field” means graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the announcement of the examination results for the first examination available after a student completes an applicable educational program.
- “Placement Rate Employed in the Field” is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.
- “Number of Graduates Taking Exam” is the number of graduates who took the first available exam in the reported calendar year.

- “First Available Exam Date” is the date for the first available exam after a student completed a program.
- “Passage Rate” is calculated by dividing the number of graduates who passed the exam by the number of graduates who took the reported licensing exam.
- “Number Who Passed First Available Exam” is the number of graduates who took and passed the first available licensing exam after completing the program.
- “Salary” is as reported by graduate or graduate’s employer.
- “No Salary Information Reported” is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information.
